- Mike and staff produced a demographics spreadsheet that lists every fire department in Vermont and how many active members we have on record for each department. Mike will send the spreadsheet to Dean to compare with the VSFA's membership list. The list will also be sent to Brad to obtain the career firefighter numbers. There are currently 3,918 active firefighter records in the Fire Academy system. Active means they've touched Fire Academy services within the past 10 years. It has been noted that the age groups of the firefighters are important to document. The

next step for the spreadsheet is to break it out by age and gender. Cindy mentioned that a subcategory of years of service would be a beneficial data point.
