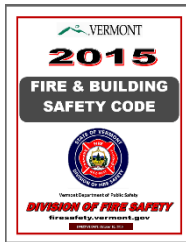




## CODE INFORMATION SHEET

# Vermont Adopted Rules, Codes, and Standards



### The Vermont Fire & Building Safety Code

These rules are adopted under 20 V.S.A. Chapter 173, Subchapter 2 “Fire Safety Division”, Subchapter 3 “Fire Hazards and Dangerous Substances”, Subchapter 5 “Boilers and Pressure Vessels” and Chapter 177 “Explosives and Fireworks”, and shall be known and cited as the Vermont Fire & Building Safety Code – 2015.

It is the intent of these rules to adopt nationally recognized safety standards and are amended to address conditions specific to Vermont. These rules provide for the public safety as directed by Vermont law.
