- (1) All Plans produced by a licensed design professional shall be stamped as such regardless of the work being performed
- (2) Stamped plans shall be required when the project size **OR** cost are equal to or greater than the numbers specified in this table
 - This table is only a guideline. The AHJ can require involvement of a design professional based on the scope of any given project regardless of the size or cost
- (3) All rehabilitation work that affects fire rated designs greater than 2 hours, any fire wall, all Type 1 and Type 4 construction shall require stamped plans
- (4) Any change of occupancy within the same hazard classification or to a lesser hazard classification shall not require stamped plans unless required by another section of this document or when required by the Authority Having Jurisdiction
- (5) Any addition greater than one story shall require plans stamped by a Licensed Design Professional
- (6) Stamped plans are only required for multi-family buildings containing more than 4 dwelling units
- * * A construction permit shall be required regardless of the size or cost of the project unless specifically waived by the AHJ
- * * Construction permit applications and submittals shall be in accordance with the Vermont Fire and Building Safety Code Section 4
- ** Refer to NFPA 101 chapter 43 for definitions of Addition, Reconstruction, Modification, Renovation and Change of Occupancy
- * * These guidelines do not supersede the rules contained within the Architects and Professional Engineering Licensing and Registration Laws (26 V.S.A Chapters 3 & 20)
